1. **2015 ASSOCIATION PRESIDENT:** Allen E. Schoppe was elected National President by the Association Board of Directors last August 2014. Look for his message in the WINTER 2014 Paraglide via the Association website-homepage, at the Paraglide link. As you know, we are trying to change our non-profit status from a 501(c)4 non-profit to a 501(c)(19) non-profit. Please see the attached letter explaining the guidelines.

5. **CHAPTER DELEGATES TO THE 2015 CONVENTION:** Chapter Officers are reminded to designate their Delegate(s) to attend the Convention by May 2, 2015. As outlined in Article IV, Section 6 (page 6-7) of the Association By-Laws, the Association President can call a Delegates' meeting sixty (60) days in advance of the Convention date. In the past, Presidents have done this because there is ample time during AAW for the Delegates to discuss issues and formalize the presentation to be given to the Board of Directors during the Convention. The one hour Delegates' meeting during the National Convention is to refresh everyone's memory and finalize the presentation. Delegates should be familiar with the Association and Education Fund By-Laws, Awards SOP, Convention SOP and National Bulletins. If the Chapters have any issues, please submit a 2-3 sentence summary to the National Office by May 2, 2015. We will include these in the Delegates' agenda.
6. **WINTER 2014 PARAGLIDE:** The Winter 2014 Paraglide is now available on line via our website at www.82ndairborneassociation.org. Please notify your members of the online availability of the Paraglide and that we are working toward producing a hardcopy for a yearly subscription of \$30.00. We have attached a copy of the Paraglide subscription form, which can also be found on the Association website.
7. **SPRING 2015 PARAGLIDE ARTICLES:** The Spring 2015 Paraglide article submission deadline is 30 March 2015. News, letters and emails should be sent directly to Holmesteads, 18865 Edwards Grove Dr., Noblesville, IN 46062, paraglide@holmesteads.com 317-674-3717. Chapter Officers are asked to adhere to the half page limit for Chapter Articles. A complete guide is published in the back of the Paraglide for your review.
8. **WITHIN FORT BRAGG & THE DIVISION:** The 82nd Airborne Division has given the green light for 2015 All American Week, scheduled for 18-21 May 2015. The Division begins the week activities with the Monday, May 18th "Division Run", followed by two (2) days of 'Athletic Events' competition. On Wednesday, May 20th there is a 'Division Review Rehearsal' at Pike Field, immediately followed by a 'Division Memorial Ceremony Rehearsal' at the Division Museum entrance. On Thursday, the "Division Review" at Pike Field attracts the "Old Timers" (Veterans march to open the ceremony), with thousands of Troopers' Families and guests from the local community observing. Immediately following, hundreds move to the Division Museum entrance/parking for the Division 'Memorial Ceremony' wreath-laying to honor 82nd Troopers who have made the ultimate sacrifice from WWI through the current War on Terror and also honor Gold Star Families. When we receive an exact schedule of events, we will post it on our website.
 - a. This past month, more than 1,000 Paratroopers from the 3rd Brigade Combat Team deployed to Iraq in support of Operation Inherent Resolve. During this rotation, they will coach, teach and mentor Iraqi Security Forces to enable them to fight ISIL.
 - b. The Division's 2nd Brigade Combat Team recently executed an Emergency Readiness Deployment Exercise, testing the unit's ability to deploy on short-notice to anywhere in the world.
 - c. The 18th Fires Brigade will officially be realigned under XVIII Airborne Corps as of 16 February 2015.
 - d. The Division will conduct a major training exercise in the month of April, collaborating with a battalion from the UK's 16 Air Assault Brigade as we continue to strengthen our partnership with our international partners.
 - e. The 82nd CAB continues to support the Resolute Support Mission in Afghanistan, providing coalition ground forces with crucial air assets all throughout Afghanistan.



- f. SFC Cheri Lee, a 3rd Brigade Career Counselor, was recently recognized as the FORSCOM Career Counselor of the Year.

9. **2015 OFFICERS & DIRECTORS TERM OF OFFICE**: In accordance with the Association By-Laws, the 2015 Officers and Directors of the Association assume office on 1 January, and end their term on December 31st. 10. **2015 COMMITTEES**: President Allen E. Schoppe has announced the Committee appointments for 2015, and the Committees' page is included for your Chapter continuity file and for dissemination to your Chapter membership.
11. **2014 CHAPTER FINANCIAL STATEMENTS**: 2014 Chapter Financial Statements, required to be furnished by all Association Chapters for inclusion in the Association Group Federal Income Tax Return, have been mailed to all Chapter Chairpersons on January 15th. Please note that there is *a suspense date of 10 April 2015* to the National Headquarters.
12. **MEMBERSHIP DUES AND CHITS**: We are receiving membership applications that reflect our old dues of \$35.00 per year. Please update all membership forms that you have to reflect the current dues as \$25.00 per year. In conjunction with over-payments, National will no longer be issuing Chits. Instead, we will be contacting the member and asking if they would like the overpayment applied to the following year's dues or if they would like to make a donation to the General Fund.
13. **82D AIRBORNE DIVISION ASSOCIATION EDUCATION FUND INC. ADDRESS CHANGE**: The Association's Education Fund has its own 501(c)(3) bank account and its new address is 82D Airborne Division Association Education Fund, Inc., P.O. Box 87482, Fayetteville, NC 28304-7482. We are combining the Association, Wounded Warrior Fund and Education Fund post office box addresses in an effort to reduce Association costs.
14. **WOUNDED WARRIOR FUND**: Contributions should be mailed to the 82nd Airborne Division Association, P.O. Box 87482, Fayetteville, NC 28304-7482.
15. **CHAPTER CHANGE OF LEADERSHIP**: Officers are reminded that leaders must be current Association members and their information submitted to the National Office as soon as possible; i.e. full name, address with 9-digit zip code, 10-digit telephone number and email address-if available. In order to ensure a smooth transition, please be sure to brief the incoming officers on Chapter files, reports, and procedures, as well as updating bank accounts.
16. **IRS LETTERS TO CHAPTERS REGARDING FY 2013**: The National office has received calls, emails and mail from Chapters that have received letters from the IRS concerning filing of Form 990. The Association CPA has contacted the IRS and is taking care of this issue. If you are still receiving notifications regarding 2013, please forward them to National as soon as possible so that we can give them to the CPA for further action.



17. **2015 CHAPTER ROSTERS:** We are in the process of updating all Chapter rosters and hope to have them out within the next couple of weeks. We appreciate your patience as we update our records.
18. **CHANGE OF ADDRESS & TAPS:** Chapters should contact their members annually via phone, mail, email, etc. and in doing so, identify changes of address. Most Chapters know their “Snow-Birds” that move in the Fall and Spring. Also, before reporting TAPS name(s) to National, it would be helpful if the Chapters gather deceased/bio information, i.e. spouse name, number of children, unit(s) served and deceased date. Notification via email with as much information as possible, together with an obituary, would be greatly appreciated. The “Address Changes” link on the Association website is an expeditious method of notifying National.
19. **2014 & 2015 CHAPTER ACTIVITIES REPORTS:** Per the Association By-Laws, “a report of the dates and places of all meetings and activities held or sponsored by the Chapter throughout the 2014 year, and ‘tentative’ schedule of the Chapter’s meetings and activities for 2015” should arrive at the National Headquarters by January 30, 2015. If you have not yet submitted your report, please do so as soon as possible. Thank you to those Chapters that have forwarded their reports. Thank you all for your continued support!

TO ALL 82D AIRBORNE DIVISION ASSOCIATION CHAPTERS:

The Association has been discussing for a long time changing our non-profit status from a 501(c)(4) non-profit to a 501(c)(19) non-profit. If our Association becomes a 501(c)(19) non-profit, donations are deductible as charitable contributions on the donor's federal income tax return. This means our Chapters as well as our Association could seek and receive donations from companies where before it was difficult because donations to a 501(c)(4) non-profits are not deductible as charitable contributions on the donor's federal income tax return. To qualify for a 501(c)(19) non-profit we must prove that at least 90% of our organization's membership consists of war veterans. The term war veterans means persons, whether or not present members of the U.S. Armed Forces, who have served in the U.S. Armed Forces during a period of war. They do not need to be combat veterans, just served during a period of war.

Your Board of Directors has decided on a way to change our IRS non-profit status and remain in compliance with the IRS regulations. First we must be able to prove to the IRS, if we are audited, that our members meet the qualifications. To meet the qualification, our chapter members must update their application with dates of service and include a copy of their DD-214 or other forms of documentation such as an order, award, a military diploma, or anything that has the member's name and date of their military service.

To start, your Chapter will receive a membership list of your Chapter members from our National Headquarters. The process your Chapter will use is your Chapter will have two lists of membership, a verified and unverified membership list. The verified list is all members who have updated their application and supplied their documentation. The unverified list is all the members who have not updated their application. Now here is the catch, only the verified membership list will count for membership. The unverified list of members are still your members but are not counted for membership. You can move members from the unverified list to the verified list as they update their application with their service dates.

Getting members to update and verify their service dates is the only way the Association can be sure we are in compliance with the IRS regulations. This will take time for your Chapter to contact your membership and update records. However this process will allow the Association to file for the 501(c)(19) non-profit status. The Association wants to file this summer or sooner, so we need your chapter to start getting your members' applications updated and mailed to our National office as soon as possible.
